1 Having reviewed the stipulation of Lead Plaintiffs Huaiyu Zheng, Abdul
2 Baker, and Zhibin Zhang (collectively, “Lead Plaintiffs”) and Defendants Funko,
3 Inc., Brian Mariotti, Jennifer Fall Jung, Andrew Perlmutter, Ken Brotman, Gino
4 Dellomo, Adam Kriger, ACON Investments, L.L.C., ACON Funko Manager,
5 L.L.C., ACON Funko Investors, L.L.C., ACON Funko Investors Holdings 1,
6 L.L.C., ACON Funko Investors Holdings 2, L.L.C., ACON Funko Investors
7 Holdings 3, L.L.C., and ACON Equity GenPar, L.L.C. (collectively,
8 “Defendants”), and good cause appearing therefore, the Court hereby ORDERS
9 that:

10 A. The Settlement Fairness Hearing is set for November 7, 2022 at 2:00 p.m.


11 B. Settlement Class Members may request exclusion from the Settlement
12 Class up to twenty-one (21) calendar days before the Settlement Fairness Hearing.

13 C. Lead Plaintiffs shall file papers in support of final approval and
14 application of Lead Counsel for attorneys’ fees, reimbursement of expenses, and
15 an award to Lead Plaintiffs, and application for approval of the Plan of Allocation
16 no later than thirty-five (35) calendar days before the Settlement Fairness Hearing.

17 D. Lead Plaintiffs shall file reply papers in support of final approval and
18 application of Lead Counsel for attorneys’ fees, reimbursement of expenses, and
19 an award to Lead Plaintiffs, and application for approval of the Plan of Allocation
20 no later than seven (7) calendar days prior to the Settlement Fairness Hearing.
